Government In G.O Ms NO: 100, Finance [DCM-III] Department, Dated: 22/04/2013 have issued orders lifting ban on transfers to the employees working in the State. The Higher Education Department will issue separate guidelines in this regard shortly

In this regard, the detailed schedule of transfers only in respect of Principals of Government Junior Colleges to be followed is given below

1	Last date for receipt of request transfer applications	30/04/2013 upto 5:00 pm
2	Display of lists of candidates liable for transfer and list of applications for request transfer	01/05/2013 till 5:00 pm
3	Publishing list of vacancies	01/05/2013 by 11:00 am
4	Last date for receipt of objections and display of final list	03/05/2013 by 5:00 pm
5	Conduct of counseling	From 3:00 pm on 04/05/2013
6	Lists to be submitted to C.I.E Office through special messenger	06/05/2013 by 11:00 am
7	Transfer orders to be issued by C.I.E Office	By 5:00 pm on 06/05/2013

The formats which were issued during last year holds good. The candidates who are liable for transfer shall be first called for counseling for all the existing clear vacancies. Only after completion of counseling of candidates liable for transfer, counseling for candidates who have completed 02 years of service and above and who have requested for transfer will be taken up for the left over vacancies

Further it is informed that, counseling in respect of Principals of Government Junior Colleges in **Zone- V, VI and City Cadre** will be conducted in the Meeting Hall, O/o Commissioner of Intermediate Education, Andhra Pradesh, Hyderabad on 04/05/2013 [afternoon] and for the remaining Zones, counseling will be conducted at their respective R.J.D Offices
