Sub: INTERMEDIATE EDUCATION - Minor repairs, white wash and Painting to Government Junior Colleges Permission to utilize Accumulated Special Fee Funds - Orders - Issued.

There is a need to carryout annual maintenance & minor repairs to all Government Junior College buildings in the State. This has to be done well before the colleges start functioning from 1st June, 2013. Representations have been received from several Principals that there are colleges with damaged black boards, broken furniture, doors and windows & poorly maintained toilets, non-functional drinking water system etc. In all cuch pages minor improvements have the beginning to the content of the co water system etc. In all such cases minor improvements have to be carried to keep the buildings in good condition. Keeping the above in view, the following instructions are issued:-

The Principal is permitted to spend an amount not exceeding to Rs.30,000/-(Rupees Thirty thousand only) from accumulated special fee fund to carryout essential repairs including white wash, painting, repairs to drinking water system and toilets, repairs to doors and windows, electrical wiring etc. The Principal shall convene the College Development Committee meeting and

discuss the matter in advance and take specific approval.

[iii] A works committee shall be constituted with Principal as convener along with two teaching staff as members who will monitor the progress daily. The Committee shall first list-out minor repairs to flooring, doors and windows, repairs to black Boards, repairs to drinking water system and tollets in the first instance

[iv] After completion of all repairs, only then they should carryout white wash and painting of buildings.

[v] They should get suitable estimates prepared wherever necessary by following

proper procedure.

[vi] They should compulsorily take Photographs Before, During and After

carrying out minor repairs and whitewashing.

[vii] The Principal shall ensure that all rules are followed while taking up the above said works and the Accumulated SPF amount shall be utilized to undertake the required tasks only.

These funds shall not be wasted on unproductive items like false-ceiling and vitrified tile flooring etc., in Principal room

This Circular is applicable to colleges which are having own buildings & furniture. Those colleges which have got major facelift only last year and those which got new buildings last year shall not utilize these funds for repairs. pertaining to setting-up of computer room under ICT Project and which falls within the scope of responsibility of the college can be carried-out.

If any college intends to spend more funds on maintenance work they may list-out the problems, prepare brief estimates and send justification proposals along with

The District Vocational Education Officer concerned shall monitor the works and submit a consolidated report of the district by 30-7-2013. The receipt of this Circular should be acknowledged.
