Sub:- **Intermediate Education** – Enhancement of seats in Government Junior Colleges in the state for the academic year – 2013-2014 – Orders Issued.

Read:- Proposals received from District Vocational Education Officers/Principals of Government Junior colleges in the state.

Permission of the undersigned has been sought for enhancement of seats from 110 to 150 in each section / group during the academic year 2013-2014 in respect of certain Government Junior Colleges in the state.

It is noticed that in certain Government Junior Colleges, there is huge demand for certain courses and students are approaching Principals for admission. Further there are several representations from Public Representatives as well in this matter.

In view of the above and after careful examination permission is hereby accorded to the Principals of Government Junior Colleges **to admit students upto 150** in all sanctioned sections/groups for the academic year 2013-2014 subject to the following conditions:-

1. The existing staff will be utilized for the academic work/instruction as far possible.
2. Additional staff will be considered if student strength exceeds 150.
3. The special fee should be same and uniform.
4. Special Fee Funds can be utilized with CIE approved to improve any infrastructure due to higher student intake.
5. Where the infrastructure facilities are poor and where there is no special fee fund available such colleges shall send special proposals to CIE for upgrading.
6. The terms & conditions prescribed by the Board of Intermediate Education shall be strictly adhered.

**Opening of Additional Sections:**

The Principals are hereby informed that, if there is demand for more than 150 seats in any section or group they are permitted to open a new section straightaway. No special permission is needed to admit 150 students or even more in a class. They can also open new section if the students strength in a group/course exceeds 150. They shall only send proposal for additional staff with proof of student strength for taking further action in the Head Office subsequently.

The receipt of these proceedings should be acknowledged.
