The skills inculcated in Govt. Junior Colleges through practical experience are to be practiced and refined through OJT. Every learner offering any vocational course has to undergo OJT for a specific period in a related industry. For this purpose 'industry' is understood in a wider sense, it implies any such organization [or even an individual entrepreneur] that has direct relevance with the vocational course offered, has a set up of a real work-place and has potential for employment. The students have to consolidate their learning, practice skills at a real work place, learn of communicate, solve problems and achieve time targets. For this, they have to undergo OJT and this is the responsibility of Govt. Junior Colleges offering vocational courses to forge such linkages with the related industries so as to be able to appropriately place every vocational student for OJT. Vocational Lecturers may play an important role in this.

In view of the above, the following committee is constituted with instructions to visit the Government Junior Colleges where the Vocational Courses are functioning and to submit a report on OJT (ON THE JOB TRAINING) Programmes conducting at +2 Level in the State.

GUIDELINES FOR THE INSPECTION TEAM ON OJT (ON THE JOB TRANING)

- 1. To check the appointment of Vocational Junior Lecturer as Co-ordinator for OJT arrangements for each course by the principal.
- 2. To check the **consent** from the identified firm/ agency for conducting the OJT for students.
- 3. Fixing up of the Schedule for OJT ((i.e) duration, Training Schedule, Evaluation etc.
- 4. Checking the attendance of the students (as OJT is compulsory) & Daily Practical work diary.
- 5. Checking the attendance of OJT Co-ordinator (JL) along with the students at the OJT centre.
- 6. To ensure the facilities provided at the centre for the students.
- 7. Visit of the principal to OJT centre and progress details.
- 8. Inspecting team shall also visit the OJT centres for Evaluation.
