- 8. Medical Bills
- 9. Discharge Summery
- Dependent Certificate to be attested by Gazetted Officer (if the treatment is taken for the dependents of the Govt. Employees or Pensioners).
- PPO (Pension Payment Order) for pensioners.
- Non drawal certificate (Certain Principals are not mentioning the amount in NDC hence it is informed to mention the amount claimed).
- 13. Referral hospital letter. (Recognized hospital G.O. Copy)
- 14. The proposals should be sent in 1 set of original documents, 2 sets of attested Xerox copies.

Note: - The claim for Medical Reimbursement should be within a period of six months from the date of discharge of the patient from the hospital.
