Sanction of New Groups & additional sections - Orders - Issued.

Read : 1) Proposals received from certain Principals of G.J.C.'s & D.V.E.O.s
in the State.

Proposals have been received from certain Principals of Government Junior
Colleges & D.V.E.O.s in the State for sanction of New Groups & additional sections
in various colleges.

After careful examination of the proposals all the District Vocational
Education Officers in the State are hereby delegated powers to issue suitable orders
on the request for sanction of New Groups & additional sections in Government
Junior Colleges under their jurisdiction under the below mentioned conditions :-

- [a] The D.V.E.O. concerned shall physically verify the infrastructure facilities
available in the G.J.C., and satisfy whether there is absolute necessity for
New Group & additional section, sufficient class rooms, furniture and other
facilities.
- [b] Any proposal shall not be considered when there is a requirement of
additional staff. There should not be additional financial burden to the
Government what-so-ever including engaging of the Contract Faculty in the
matter. Only existing staff shall be utilised keeping in view of economy
measures issuing by the Government every year.
- [c] The fee should not be enhanced and it shall be same and uniform in case of
New Group & additional section now required.
- [d] There should be minimum/economic strength in New Group & additional
section now required.
- [e] The D.V.E.O. shall mention to the Principal, G.J.C. concerned that, the
minimum/economic strength shall be maintained for New Groups &
additional sections now required every year. They shall also mention that,
if the group/section now required is not having minimum/economic
students strength for three(3) continuous academic years, it shall be
deemed to be abolished.
- [f] The DVEO shall mention that, the norms/terms and conditions prescribed
by the Board of Intermediate Education, A.P., Hyderabad in this regard
shall be strictly adhered.

The District Vocational Education Officers in the State are also instructed
that, they shall mention the above conditions while issuing of orders to the
Principals of Government Junior Colleges concerned.

These proceedings should be acknowledged.
