G.O.Ms.No.98, Finance (HRA I) Department, dated 04.08.2015 and G.O.Rt.No.389, School Education (IE) Department, dated 08.08.2015, have issued orders lifting ban on transfers to the employees working in the State. Government have also issued guidelines with regard to transfers to employees working in the Department of Intermediate Education vide reference 3rd cited.

Basing on the above said orders, the undersigned in his orders dated: 08.08.2015 while communicating the guidelines has formulated time schedule for effecting transfers by way of counseling at O/o Regional Joint Director of Intermediate Education, Kadapa in a fair & transparent manner.

Accordingly the time schedule for counseling has been communicated. The available vacancies have been displayed at O/o the Regional Joint Directors of Intermediate Education and O/o the District Vocational Education Officer concerned and candidates have been called for counseling to exercise their options to the places of their choice and accordingly counseling has been held on 16.08.2015 at Regional offices concerned. The individuals have attended the counseling and has opted Government Junior Colleges in a fair and transparent manner.

Accordingly, the Principals of Government Junior Colleges in Zone-IV as shown in Annexure- I, who have completed more than 05 years of stay in the present station are hereby transferred compulsorily. All these Principals are posted to Government Junior Colleges as noted against their names as shown in Annexure-II, who have completed a minimum of 02 years of stay at their present place and who requested for transfer on various grounds were examined and some of them were considered purely based on merits.

The Principals of Government Junior Colleges in Zone-IV as shown in the Annexure- I and II are requested to get themselves relieved from the post of Principal by handing over the complete charge to the senior most qualified and eligible regular Junior Lecturer of the College and join at new station and report compliance. With regard to the places, where no regular Junior Lecturer is available in that College, the Principals who got transferred under liable transfers will join their new places, immediately.

The District Vocational Education Officer concerned shall identify the senior most Junior Lecturer in the District and arrange F.A.C. to such Colleges immediately. The D.V.E.O. should also ensure that, the person who is posted to such Colleges shall work as Principal (F.A.C.) on full time basis and shall not be allowed to shuttle between his previous station where he is Junior Lecturer and the new place where he is Principal (F.A.C.). These F.A.C. Principals shall also take classes compulsorily in their subject.

With regard to the request transfers, the Principals who opted places will be relieved only after joining of regular Junior Lecturer / Principal.

The dates of relief and joining duty shall be reported promptly. It is further instructed that as per the instructions issued by Government, the transferred employee is deemed to have been relieved from his/her present station at the end of seven days from the date of receipt of this order.

The individuals are not entitled/eligible for any T.T.A/T.A/D.A etc, as the place of posting is issued at their request in the counseling.

Any deviation in this regard will be viewed seriously.

The receipt of these proceedings shall be acknowledged.
