ward and housekeeping services on outsourcing basis - Orders-

Several requests have been received from Zonal, District level and from the Principals of various Government Junior Colleges for enhancement of monthly honorarium sanctioned vide reference 3rd read above from Accumulated Special Fee Fund (ASFF) of the college to each to Night Watchman/Sweeper/Scavenger engaging on outsourcing basis.

In view of the above, Principals of Government Junior Colleges are permitted to utilize the Accumulated Special Fee Funds for engaging a **Night Watchman, Sweeper & Scavenger** on outsourcing basis as per need until further orders duly following the rules in vogue. The remuneration shall be a maximum of Rs.2,500/- per month for each **Night Watchman, Sweeper & Scavenger**.

The above permission is subject to the following conditions :-

1. Availability of required funds under Accumulated Special Fee Funds in the College.
2. Such services can be hired only when the regular Watchman/Sweeper/Scavenger is not available in the college.
3. Only when specific permission not accorded in the matter from the competent authority until further orders.
4. The resolution of Special Fee Committee to utilize Special Fee/Caution Money Deposits is necessary before engaging such services on outsourcing basis.
5. The names of persons engaged on outsourcing basis should not be brought on regular attendance registers/College rolls or even in any official correspondence under any circumstances.

All the Principals are also permitted to utilize **Rs.500/- per month** from Accumulated Special Fee Funds for purchase of Brooms, Phenyl, acid, Naphthalene balls, dustbins, etc., to maintain the premises including Toilets, labs etc in hygienic condition. They are instructed to get Fans, Windows, Doors cleaned and cob-webs removed regularly in the premises. They should give priority to maintenance of cleanliness in the college.
